



Franklin Park Conservatory Social Media Contest Rules – Children’s Garden Trivia Contest

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A purchase will not increase your chances of winning. Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. The Children’s Garden Trivia Contest ("Contest") will be held online from 12:00 a.m. Eastern Time ("ET"), March 31, 2018 ("Contest Start Date"), to 11:59 p.m. ET, May 15, 2018 ("Contest Period"). Contest is sponsored by Franklin Park Conservatory and Botanical Gardens (the "Sponsor") who is solely responsible for all aspects of this Contest.
