



Franklin Park Conservatory Social Media Contest Rules – Visitor Surveys

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A purchase will not increase your chances of winning. Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. Visitor Surveys ("Surveys") will be conducted online from 12:00 a.m. Eastern Time ("ET"), February 1, 2019 ("Survey Start Date"), to 11:59 p.m. ET, March 1, 2019 ("Survey Period"). The Survey is conducted by Franklin Park Conservatory and Botanical Gardens (the "Sponsor") who is solely responsible for all aspects of this Survey.

2. ELIGIBILITY. The Survey is open to legal residents of the United States of America who are 18 years of age or older as of "Survey Start Date." Sponsor's employees and their immediate families are not eligible to participate or claim a prize. Void where prohibited or restricted by law. All federal, state and local laws, rules and regulations apply. By participating, entrants agree to abide by all terms of these Official Rules and to the decisions of the judge and waive any right to claim ambiguity in the Survey or these Official Rules.

The Sponsor assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, entries.
