



Franklin Park Conservatory Social Media Contest Rules – #FranklinParkConservatory Photo Contest

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A purchase will not increase your chances of winning. Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. The #FranklinParkConservatory Photo Contest ("Contest") will be held online from January 10, 2020 ("Contest Start Date") to March 29, 2020 ("Contest Period"). Contest is sponsored by Franklin Park Conservatory and Botanical Gardens (the "Sponsor") who is solely responsible for all aspects of this Contest.

2. ELIGIBILITY. The Contest is open to legal residents of the United States of America who are 18 years of age or older as of "Contest Start Date." Sponsor's employees and their immediate families are not eligible to participate or claim a prize. Void where prohibited or restricted by law. All federal, state and local laws, rules and regulations apply. By participating, entrants agree to abide by all terms of these Official Rules and to the decisions of the judge and waive any right to claim ambiguity in the Contest or these Official Rules.

- c) Multiple submissions are permitted throughout the duration of the contest.

Acceptance of a prize constitutes permission to use the winners' names, likenesses, and statements for promotional and publicity purposes without additional compensation or limitation unless prohibited by law.
