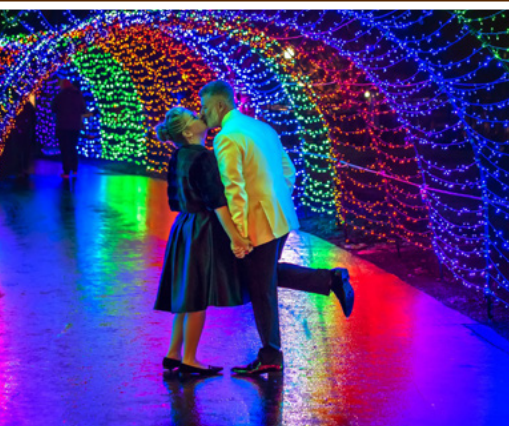

- 1895** The iconic Victorian-era glasshouse, now called the John F. Wolfe Palm House, opened to the public.
- 1974** John F. Wolfe Palm House added to the National Register of Historic Places.
- 1989** \$14 million John F. Wolfe Palm House renovation completed as part of a 58,000-square-foot expansion to facilities, including the addition of the four Conservatory biomes.
- 1992** *AmeriFlora '92*, an international horticultural exhibition, held on site and attracted more than a million visitors. Following *AmeriFlora*, ownership of the Conservatory and surrounding acreage was conferred to organizers, now a nonprofit organization with a 10-member Board of Trustees.
- 1994** Debut of *Blooms & Butterflies*, making us the first conservatory in the nation to showcase a seasonal butterfly exhibition.

## FOUNDATIONS

SINCE 1993, FRANKLIN PARK CONSERVATORY AND BOTANICAL GARDENS HAS BEEN BRINGING NATURE, PEOPLE AND THE ARTS TOGETHER.



- 2003** Successful *Chihuly at the Conservatory* exhibition led to the purchase of the permanent collection, forming what is the largest Chihuly collection in a botanical garden worldwide.
- 2009** Scotts Miracle-Gro Company Community Garden Campus dedicated, the largest public edible garden in North America at the time.
- 2015** The Wells Barn added as an extension of the existing Community Garden Campus. The timber frame that serves as the skeleton and inspiration for The Wells Barn originates from a historic barn found in Richland County, Ohio.
- 2018** Scotts Miracle-Gro Foundation Children's Garden opened to the public, boosting family memberships by 50% and tripling annual attendance revenue.
- 2022** Received \$1 million allocation as part of the State of Ohio capital bill to plan a renovation project of the John F. Wolfe Palm House, which will restore original features, improve guest accessibility and ensure that this historic structure is maintained for the next generation.
- 2023** Franklin Park Conservatory and Botanical Gardens celebrates 30 years of elevating quality of life and connecting the community through educational, cultural and social experiences inspired by horticulture.

# HEALTHY FOOD ON THE NEAR EAST SIDE

Lucy and her little brother Lincoln were Veggie Champ MVPs at the Conservatory Farmers Market, which ran weekly from June through September. Lucy, Lincoln and hundreds of other kids who checked out the new children's interactive Veggie Champ booth got to try tasty fresh samples of snap peas, kohlrabi, cucamelon pickles and more.

Fun activities like a Market Scavenger Hunt, Eat a Rainbow Challenge and Grow Your Own Microgreens got kids excited for healthy eating. Veggie Bucks, a \$2 voucher for kids to redeem at the market, let them select their very own produce from one of 28 vendors. Special thanks to market sponsors Discover, Franklin County Board of Commissioners and Osteopathic Heritage Foundations, who helped kids (and their parents) keep it fresh and fun, all summer long at the Farmers Market!

## TEEN CORPS

### GROWING TOMORROW'S LEADERS

2022 marked the 6th year of Teen Corps, a high-impact summer internship that connects teens with nature and each other. Participating teens worked in a dedicated community garden plot in the Scotts Miracle-Gro Company Community Garden Campus, growing produce and selling it through their own stand at the Conservatory's Farmers Market.

The program also helped youth learn about the environment, health and nutrition, entrepreneurship, communication and teamwork, while paying a stipend to support their education and recognize their hard work.

🌻 **19 TEENS** from 13 Columbus-area schools grew and harvested 224 pounds of fresh produce throughout the summer.

🌻 **AFTER THEIR TEEN CORPS EXPERIENCE**, 89% of participants said that they understood how gardening supports a healthy lifestyle, and the cohort demonstrated big gains in healthy behaviors.

🌻 **THE 2022 COHORT** of Teen Corps graduates will join the 60+ alumni well on their way to becoming healthy, thriving adults.

# GARDENING IS FOR EVERYONE

Since 2001, Growing to Green has helped start, strengthen and sustain hundreds of community gardens and beautification projects throughout Columbus.

Each year, the program supports hundreds of gardeners at the Conservatory and in the community through education, site visits, consultation and distribution of Garden Grants and annual Harvest Awards.

Growing to Green is based in the Scotts Miracle-Gro Company Community Garden Campus, a 4-acre green space where visitors can freely explore culinary, herb and fragrance gardens, a bee apiary, a rose pavilion, a berry house and much more!

- 🌻 **40** community garden plots on-site help to improve access to fresh food and neighborhood connections.
- 🌻 **40%** of Conservatory community gardeners were nearby neighbors from 43203, 43205 and 43209 zip codes.
- 🌻 **4** of our on-site plots are designed to be accessible for people with complex needs and were planted and maintained by local nonprofits and their clients.
- 🌻 **8** Harvest Awards totalling \$3,500 in prize money uplifted the work of community gardeners throughout the city.
- 🌻 **\$20,000** in Garden Grants were distributed to community gardens throughout Columbus in partnership with the The Columbus Foundation and Franklin County.
- 🌻 **2,000+** pounds of free community- and Conservatory-grown produce were distributed through the Free Little Farmstand.

## LEARNING IS IN OUR NATURE

Franklin Park Conservatory and Botanical Gardens is where children, families and adults turn to learn about the natural world!

- 🌿 **17,000+ STUDENTS AND TEACHERS** visited for field trips and 35 classes received field trip scholarships that brought classrooms from schools that couldn't otherwise afford to visit.
- 🌿 **500+ KIDS** participated in summer camps and nature school and 10 Camp for All Scholarships helped level access for all children, regardless of means.
- 🌿 **1,000** Columbus Recreation and Parks Department campers visited free of charge.
- 🌿 **FPC CAMP STEM** partnership with Columbus City Schools brought Conservatory educators into summer school classrooms, impacting 190 K-2 students, 90 6-8 graders, and 350 students with complex needs.







## HEAD START DISCOVERY

### HELPING YOUNG MINDS BLOOM

Touching autumn leaves, watching ice melt and burying seeds in cups of soil might seem like simple activities, but they powerfully illustrate fundamental understandings about nature and science for young children.

The Conservatory's partnership with Head Start, an early childhood education program for low-income families, continued for a second year in 2022 with support from PNC Grow up Great, Ohio Children's Foundation, and Columbus Kiwanis Foundation.

Three- to five-year-old children were treated to nature-based lessons facilitated by visiting Conservatory educators, engaging their five senses to help them learn counting, shapes, colors, and vocabulary, build critical thinking skills and strengthen an appreciation for nature that they can carry into Kindergarten and beyond.

The Conservatory had another excellent season in the Children's Garden, welcoming a total of 65,209 three- to twelve-year-old children for hands-on exploratory play, nature storytime, discovery station lessons, visits by special guest entertainers and the new Let's Grow Garden Club!

## COMMUNAL GARDEN CLASS SERIES

### LEARNING, FOR ALL OF LIFE'S SEASONS

Here at the Conservatory, we believe gardening is for everyone! 2022 marked our first year of offering a **free** monthly Communal Garden class series, a way for adult gardeners and community garden leaders to build horticulture knowledge that they can use to grow something beautiful in their communities.

112 learners took classes covering gardening topics ranging from brassicas to garlic to seasonal planting tips and tricks!

This free class series is part of the larger Conservatory Growing to Green initiative that builds capacity and helps people grow their communities through gardening.

In addition to Communal Garden classes, a total of 286 adult classes with 2,170 participants helped people from all walks of life learn about gardening, fine arts, culinary skills and glass blowing in the Hot Shop.



# PUTTING ARTISTS IN CONVERSATION

From June 25 through November 20, seven local Latinx artists displayed artwork that encouraged cross-cultural dialogue, touching on themes of dislocation, integration, identity and social history.

*Diálogos* was the second annual gallery installation highlighting the work of diverse local artists, following *Resilience in Nature* in 2021. *Diálogos* featured work in a variety of mediums and was curated by local artists Eglé Gatins and Elena Osterwalder. The show was made possible thanks to Lead Sponsor, Cardinal Health, with support from The Columbus Foundation, Greater Columbus Arts Council and Ohio Arts Council.

## TOPIARY TAKEOVER

### TRANSPORTING VISITORS AROUND THE WORLD

From June through September, guests were immersed in a wild habitat in full bloom! Twenty-three animal topiaries were hand-built and grown by Conservatory horticulturists, representing UNESCO World Heritage Sites, places most in need of cultural and environmental preservation.

Visitors were transported around the world—from Australia’s Great Barrier Reef to the Great Plains—to visit with animals including camels, tigers and a majestic peacock. A little closer to home, visitors could meet and greet a larger-than-life cardinal, the Ohio state bird, or make a wish at the lucky pot o’ gold topiary!

The topiaries used live plants to mimic the textures of feathers, fur, scales and skin, and the experience was enhanced by educational interpretation at each site featuring a playlist of world music representing the animal’s country of origin. 2022 exhibition signage also included braille and audio tour, helping to create an experience that was more accessible for visitors of all abilities. This exhibit was made possible thanks to Lead Sponsor, The Davis Foundation.

- 🌿 **OVER 8,000** individual plants were planted on the frames to create the display.
- 🌿 **MORE THAN 1,000 HOURS** of Conservatory staff time was spent creating and planting these topiary creatures.
- 🌿 **TRAVELING TOPIARIES** An extra group of Conservatory topiaries are rented each year to other museums nationwide. In 2022, our flamboyance of flamingos was on view in Los Angeles at the South Coast Botanic Gardens.

# FIVE YEARS OF CONNECTING COLUMBUS

Research shows that there is a gap in accessibility to green spaces and nature, and families with more financial resources are more likely to visit cultural organizations like ours.

Since 2018, our monthly free *Community Days* have helped to change that, ensuring that the Conservatory is an accessible destination for any Franklin County resident who wants to immerse themselves in the natural world.

*Community Day* themed programming helped the Conservatory and our neighbors celebrate Global Recycling Day, National Gardening Week, Election Day and seasonal occasions like cherry blossoms in the springtime and wintertime holidays. More than 40 partnerships with diverse nonprofits, performing arts groups and businesses were strengthened through on-site *Community Day* programming, fostering a stronger sense of community for us all.

# CONNECTING SUPPORTERS

2022 was a banner year for the Conservatory's signature mission-supporting fundraising events. In May, the Conservatory hosted the 21st annual *Les Chapeaux dans le Jardin*, or *Hat Day*. The event, planned under the leadership of co-chairs Tina Skestos & Thomas F. Havens, smashed fundraising records and netted over \$500,000 in revenue. During the event, the 2022 Ann Isaly Wolfe award was presented to long-time friend of the Conservatory, DeeDee Glimcher.

In June, more than 350 guests gathered for *Bash at the Barn*. This marked the 18th and final year of *Bash*, raising \$93,000 to help the community make meaningful, lifelong connections to nature through our horticulture, education and outreach initiatives.

In August, the Conservatory Women's Board and *Field to Table* committee, under the leadership of co-chairs Joan Kirschner and Barbara Brakemeyer Elliott, presented *Field To Table*. This beautiful farm-to-table dinner under the stars drew more than 700 community and corporate leaders and netted a record-breaking \$410,000 to benefit the Conservatory's community outreach and education initiatives.

Founded in 1984 by a few dedicated women, the Women's Board has since grown to nearly 300 members connected in a web of family, friends, colleagues, neighbors, and former strangers who have become friends, united in a sisterhood devoted to doing good.

This dynamic group serves Franklin Park Conservatory and Botanical Gardens through financial support, advocacy and volunteerism. 2022 marked another wonderful year of service and community, and the Conservatory extends our heartfelt gratitude to this exceptional group for their commitment to making a greener and healthier world for us all!

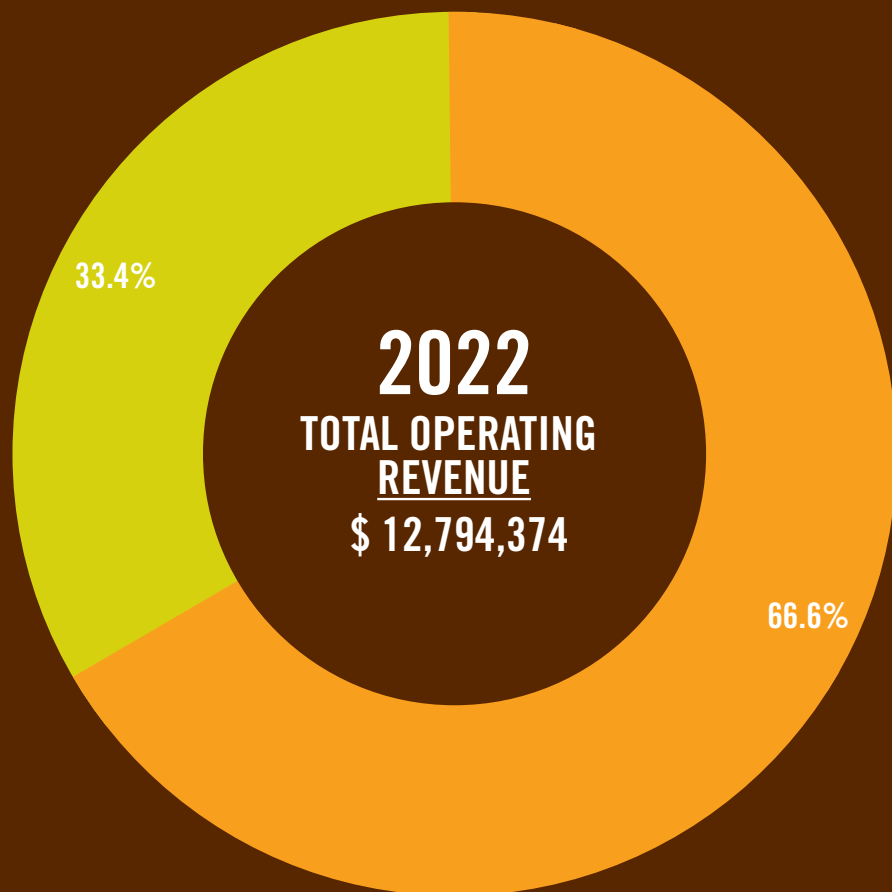
## ALEXIS JACOBS

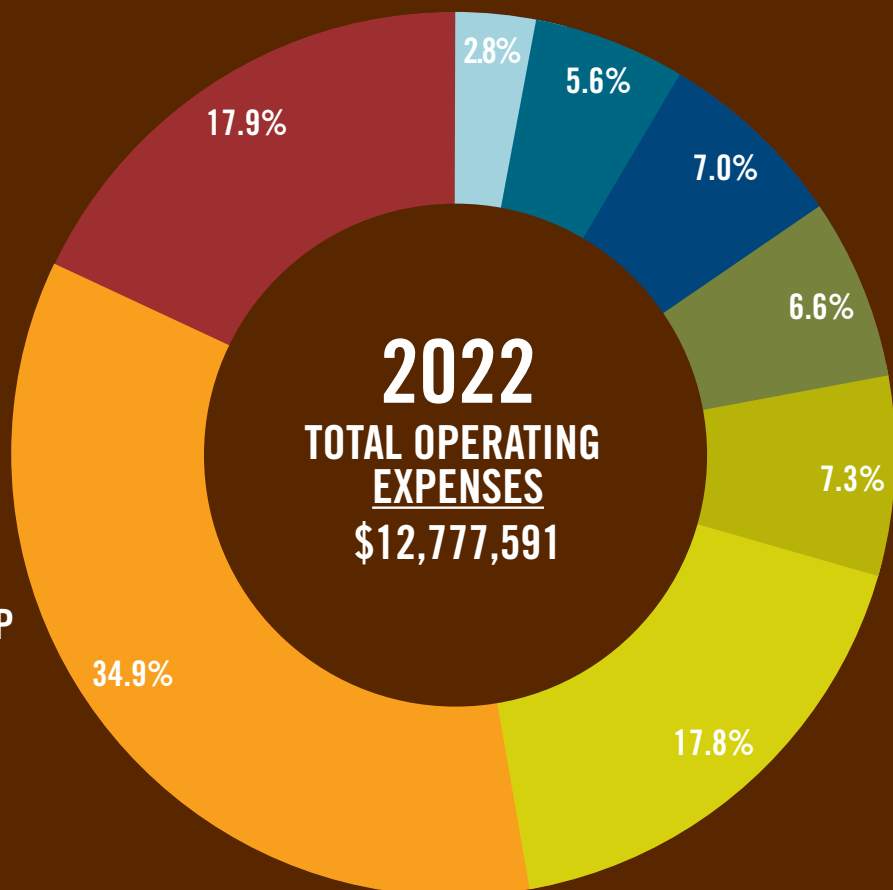
